INVESTMENT OBJECTIVE

The Balondolozzi BCI Global Equity Fund is a global equity portfolio which aims to provide long term capital growth by generating market beating returns during all market cycles.

INVESTMENT POLICY

The portable alpha strategy effectively separates the returns of a preferred index, or beta, and the returns of an alpha-seeking strategy, or alpha. The portfolio's minimum foreign exposure will be 80% of its net asset value in order to achieve its objective. The investments normally to be included in the portfolio may comprise a combination of assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing securities and instruments and non-equity securities. The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow from time to time, and which are consistent with the portfolio's investment policy. The portfolio may from time to time invest in listed and unlisted financial instruments

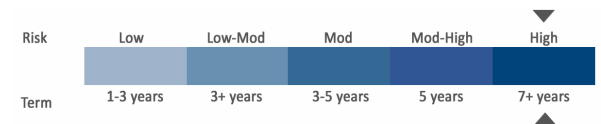
